GOVERNMENT INDUSTRIAL LAND SALES PROGRAMME FOR SECOND HALF OF 2007

The Ministry of Trade and Industry today announced the Government Industrial Land Sales Programme for the second half of 2007. There will be two sites in the Confirmed List and seven sites in the Reserve List.

2. Under the Industrial GLS programme for the first half of 2007, there were two sites in the Confirmed List. The first site at Tampines Street 92/Simei Avenue was launched for sale on 13 Feb 2007 and awarded on 11 Apr 2007 by URA. The tender for the second site at Kaki Bukit Road 3 will be launched for sale by the end of Jun 2007.

3. For the second half of 2007, MTI will place two industrial land sites totalling about 7.2 ha on the Confirmed List to meet the continued demand for industrial land. These are:

5. To meet potential demand for industrial land, four new sites at Toh Tuck Ave, Ubi Ave 4/ Ubi Road 2, Yishun Ave 6 (Parcel 8) and Toa Payoh will be introduced to the Reserve List. These are in addition to the three sites at Yishun Ave 6 (Parcel 1), Commonwealth Drive/ Commonwealth Lane and Pioneer Road/ Tuas Ave 11 which will remain in the second half Reserve List. The details are as follows:
