Mr Alexander Charles Hungate President and CEO SATS Ltd

Mr Hungate joined SATS as Executive Director in July 2013 and assumed his current role as President and CEO on 1 January 2014. He is also Board Director and member of the Board Executive Committee at SATS.

Mr Van Wersch is based in Singapore and has spent 14 years working in Asia. His 25-year career to date, has involved marketing, sales, and management roles for various multinational companies, in different regions.

He began his career at Vivendi Universal's international marketing department in Paris in 1994, then moved to Airbus, followed by Alcatel. Mr Van Wersch joined Alstom in 2006 as Vice President Sales for Europe and was promoted to Senior Vice President Asia Pacific in 2011, based in Singapore. In 2014, he was appointed the Growth Leader for the GE-Alstom integration team and was named President & CEO of GE ASEAN when the acquisition was completed in 2015. As of January 2018, he was appointed as President & CEO of the newly combined APAC region that comprises ASEAN, Australia, Japan, Korea, New Zealand and Papua New Guinea.

Mr Gan has been with ExxonMobil for more than 30 years and has held various key positions in manufacturing, planning, finance and commercial areas in Singapore and USA.
