**Professor Dipti Srinivasan**  
**Professor, Department of Electrical & Computer Engineering, National University of Singapore (NUS)**  
**Adjunct Researcher at Solar Energy Research Institute Singapore (SERIS)**

Professor Dipti Srinivasan is a Professor in the Department of Electrical & Computer Engineering, National University of Singapore (NUS), where she also heads the Centre for Green Energy Management & Smart Grid (GEMS). Her research focuses on the development of novel artificial intelligence-based models and methodologies to aid the integration of the new Smart Grid technologies into the existing infrastructure so that power grid can effectively utilise pervasive renewable energy generation and demand-side management programs, while accommodating stochastic load demand.

Professor Dipti is a Fellow of the Institute of Electrical and Electronics Engineers (IEEE) and was awarded the IEEE Singapore Outstanding Volunteer award in 2020 and Outstanding Engineer award in 2010. She is currently serving as an Associate Editor of IEEE Transactions on Sustainable Energy, IEEE Transactions on Smart Grid, IEEE Transactions on Artificial Intelligence, and journal of Solar Energy.

She was the winner of the NUS Annual Teaching Excellence Award in year 2007, 2008 and 2009, and was placed on the Honours list in 2010. She was the recipient of the Engineering Educator Award from the Faculty of Engineering, NUS in 2011 and 2012. Professor Dipti was recently awarded the 2022 IEEE PES Wanda Reder Pioneer in Power Award for her “Leadership and valuable contributions to the power engineering profession, education and excellent volunteerism”.
