## SINGAPORE MINISTRY OF TRADE AND INDUSTRY AND KOREA MINISTRY OF TRADE, INDUSTRY AND ENERGY HOLD THE FIRST KOREA-SINGAPORE DIGITAL ECONOMY DIALOGUE

Singapore and the Republic of Korea (ROK) held the first Korea-Singapore Digital Economy Dialogue in Seoul, Korea today. The Dialogue was co-chaired by Singapore's Deputy Secretary (Trade) Jane Lim and ROK's Deputy Minister for Trade Jeong Dae-jin. The Korea International Trade Association was the supporting organisation for the Dialogue.

- Public and private sector representatives from both countries gathered to learn about operationalising the Korea-Singapore Digital Partnership Agreement (KSDPA), exchange views on digital economy in Singapore and the ROK, and discuss ways to enhance collaboration between the two economies. Apart from gaining a better understanding of Singapore and ROK's digital trade policies, participants also had the chance to learn about the offerings from leading Singapore enterprises such as Singtel, Filmplace, M-DAQ and Trustana, and Korean enterprises such as NAVER Cloud, Hyundai Motors, EntreReality and H20 Hospitality.
- 3 Enterprise Singapore, the Singapore Economic Development Board, and the Infocomm Media Development Authority facilitated arrangements by identifying and introducing suitable Singapore companies for the Dialogue. The Dialogue provided an opportunity for Singapore enterprises to engage Korean public and private sector agencies on digital trade technologies and services. Singapore enterprises also used the Dialogue to connect with Korean enterprises.
- Deputy Secretary Jane Lim said, "Through the Dialogue, stakeholders from both sides engaged on issues related to digital economy and explored mutually beneficial business opportunities in Singapore, Korea, and the region. By bringing together public and private sector players with complementary knowledge and expertise, I believe that the Dialogue will be an important platform for promoting further cooperation between Singapore and Korea in the digital arena."
- Deputy Minister Jeong Dae-jin said, "Singapore is an ASEAN digital hub with excellent ICT infrastructure and a liberal business environment, which, when combined with Korea's competitive ICT and manufacturing technologies, will provide great synergies for cooperation. We expect the KSDPA and the Digital Economic Dialogue to be the foundation for mutually beneficial and future-oriented cooperation between the two countries."
- Singapore and ROK share strong economic ties. In 2022, ROK was Singapore's 7<sup>th</sup> largest trading partner, with merchandise trade amounting to S\$70.9 billion, a 26% year-on-year increase. As of end-2021, Singapore was ROK's 9<sup>th</sup> largest source of investments in Asia with cumulative investments of about S\$14.1 billion. ROK was Singapore's 6<sup>th</sup> largest source of investments in Asia, with a cumulative direct investment of S\$35.5 billion.
- Following the successful conclusion of the inaugural Korea-Singapore Digital Economy Dialogue, Singapore and ROK would explore holding the next Dialogue in the near future.

## Annex C: Factsheet on the Memorandum of Understanding on Implementing the Korea-Singapore Digital Economy Dialogue

- 1 The Ministry of Trade and Industry of the Republic of Singapore and the Ministry of Trade, Industry and Energy of the Republic of Korea (ROK) signed the Memorandum of Understanding (MOU) on Implementing the Korea-Singapore Digital Economy Dialogue on 21 November 2022.
- The MOU aims to advance the implementation of the Korea-Singapore Digital Partnership Agreement (KSDPA) by establishing a Korea-Singapore Digital Economy Dialogue, a platform to promote digital economy collaboration between Singapore and the ROK.
- The Dialogue aims to facilitate discussion on digital trade and strengthen the international competitiveness of Singaporean and Korean digital industries, and to encourage relevant stakeholders from both sides to explore mutually beneficial business opportunities in Singapore, the ROK, and other markets. Both sides may organise webinars, forums, workshops and roundtables to expand opportunities for inter-industry exchanges.
- 4. The MOU reaffirms the close working relationship between Singapore and the ROK, and demonstrates the strong commitment from both sides in implementing the KSDPA to strengthen academic and industry exchanges to benefit our people and businesses.
