SINGAPORE AND VIETNAM ADVANCE BILATERAL COOPERATION IN NEW AND EMERGING SECTORS

*Second Minister Tan See Leng co-chaired the annual meeting which saw the inclusion of new topics and expanded agency representation on both sides. He also co-witnessed the signing of an MOU on innovation cooperation between A*STAR and Vietnam's National Innovation Center.*

1. Second Minister for Trade and Industry Dr Tan See Leng co-chaired the 17th Singapore-Vietnam Connectivity Ministerial Meeting (CMM) held in Hanoi, Vietnam today.
2. Together with his counterpart, Vietnam Minister of Planning and Investment H.E. Nguyen Chi Dzung, Minister Tan led discussions on collaborating in new and emerging areas of Energy Connectivity, Sustainability and Digital and Innovation. The Ministers also noted progress made in the areas of Education, Finance, Information Technology and Telecommunications, Infrastructure, Investment, Tourism, Trade and Services, and Transport since the last meeting. The expansion of topics covered by CMM reflects the changing and expanding economic partnership between Singapore and Vietnam.
3. The CMM is the key economic platform established under the Singapore-Vietnam Connectivity Framework Agreement (CFA) signed between Singapore and Vietnam in 2005. In line with this expansion, side letters on the CFA upgrade to reflect the new pillars of cooperation will be exchanged between Minister Tan and Minister Dzung on 28 August 2023. The exchange will be witnessed by Prime Minister (PM) Lee Hsien Loong and Vietnam PM H.E. Pham Minh Chinh.
4. Minister Tan said, "Singapore and Vietnam share strong and substantive trade and investment ties. With Vietnam's transition to the green and digital economy, Singapore can be a partner to Vietnam in its next bound of growth. Singapore companies can build on the strong foundation and partnerships with Vietnam to capture opportunities in these new areas."
5. On the sidelines of the 17th CMM meeting today, the Ministers also witnessed the signing of a Memorandum of Understanding (MOU) between Singapore's Agency for Science, Technology and Research (A*STAR), and Vietnam's National Innovation Center (NIC). (*Annex B – Info on the MOU*)

6. The 17th CMM follows Minister Tan's recent visit to Vietnam from 5 to 7 July 2023, where he met key government counterparts to discuss strengthening

bilateral cooperation in key economic areas and attended the 7th Singapore Regional Business Forum (SRBF) as the Guest of Honour.

7. Singapore companies have steadily expanded their investments throughout Vietnam, in diversified sectors including logistics, infrastructure, manufacturing and consumer goods and services. The economic footprint of Singapore companies can be found across Vietnam from North, Central and South, including the 13 Vietnam-Singapore Industrial parks (VSIPs). Notably, business interest in the green economy and digital economy have grown in recent years.

8. Held outside of Singapore for the first time, the 7th SRBF in July saw strong participation by Singapore business representatives and the signing of 12 MOUs between public and private sector organisations from Singapore and Vietnam. It reflected the mutual interest between businesses in both countries to forge closer partnerships. (*Annex C – Examples of Singapore companies operating in Vietnam*)

Strong and Substantive Economic Ties

9. Singapore and Vietnam share strong bilateral economic ties. In 2022, Vietnam was Singapore's 11th largest trading partner. Bilateral goods trade grew by 16.4% year-on-year to S\$31.3 billion in 2022. Bilateral services trade grew by 9.4% year-on-year to S\$7.4 billion in 2021.¹

10. As at end-2022, Singapore was also Vietnam's second-largest foreign investor with a cumulative investment of US\$70.8 billion.²

11. 2023 is a special milestone year as Singapore and Vietnam celebrate 50 years of diplomatic relations and ten years of Strategic Partnership. From 27 to 29 August, Minister Tan will join PM Lee Hsien Loong on his official visit to Vietnam.



ANNEX B: Information on the A*STAR-NIC MOU

The Memorandum of Understanding (MOU) on Innovation Cooperation will promote collaboration activities between A*STAR and NIC in the following areas:

- Talent attraction and development through the Robot Operating System – Industrial (ROS-I) Consortium under A*STAR’s Advanced Remanufacturing and Technology Centre (ARTC), and the A*STAR Graduate Academy;
- Technology and ecosystem development with access to Vietnam’s growing markets including for Singapore’s Small and Medium Enterprises (SMEs), such as through the ARTC Consortium;
- Opportunities for collaboration in advanced manufacturing involving Singapore’s and Vietnam’s SMEs and startup companies, through ARTC and A*StartCentral (the open innovation and incubation arm of A*STAR).

Under the MOU, A*STAR and NIC will also explore a potential research collaboration project to support the establishment of NIC’s Modern Factory.

Within three years in the market, it established a presence in both Ho Chi Minh City and Hanoi and has grown to become one of the Vietnam’s largest rooftop solar developers. In addition to approximately 125-Megawatt-peak of rooftop solar deployment across the country, it acquired two utility-scale solar farms in the Phu Yen Province in early 2023. The solar farms can provide 130 Gigawatt-hours (GWh) of clean electricity annually, helping Vietnam reduce its carbon dioxide emissions by up to 105,000 tonnes annually.
