MINISTER OF STATE LOW YEN LING ATTENDS THE 20TH CHINA-ASEAN EXPO AND THE INAUGURAL CHINA-ASEAN CLEAN ENERGY WEEK

1 Ministry of State (MOS) for Trade and Industry Low Yen Ling, is in China from 16 to 19 September for an official visit. She attended the 20th China-ASEAN EXPO (CAEXPO) opening ceremony and visited the Singapore National and Commodity Trade Pavilions in Nanning today, and will be attending the inaugural China-ASEAN Clean Energy Week (CACEW) in Haikou on 19 September. MOS Low will also be meeting her counterparts and Singapore and Chinese businesses during her trip.

2 The CAEXPO is an annual trade fair and a significant platform to promote bilateral economic cooperation between ASEAN countries and China. This year marks the 20th anniversary of the CAEXPO and the first in-person Expo following three years of hybrid modality.

3 Singapore's National Pavilion, themed "Singapore – A Harmonious and Sustainable Hub for New Collaborative Growth (和谐共生"新"枢纽,携手共创"新"发展) features Singapore as an international hub with extensive connectivity and a business-friendly environment. It highlights economic cooperation between Singapore and China, as well as showcases Singapore-China Government-to-Government projects such as the Suzhou Industrial Park, the Sino-Singapore Tianjin Eco-city and the China-Singapore (Chongqing) Demonstration Initiative on Strategic Connectivity.

4 The Commodity Trade Pavilion features 22 local home-grown companies and brands, that are keen to venture further into the Chinese and ASEAN markets. The participating companies come from a range of sectors including legal and financial services, food and beverage (F&B), as well as consumer goods.

5 MOS Low said, "ASEAN and China enjoy a strong partnership, which stems from our shared commitment to work together for the benefits of our peoples and businesses. As we celebrate the 20th anniversary of the CAEXPO, I look forward to even deeper economic cooperation between ASEAN and China as we work together on the ASEAN-China Free Trade Area 3.0 Upgrade."

6 On 19 September, MOS Low will deliver remarks at the opening ceremony of the CACEW. The CACEW is co-organised by China's NEA, the Hainan Provincial Government, and Indonesia's Ministry of Energy and Mineral Resources (ESDM), the ASEAN chair for 2023. Themed "For a Shared Future: Across the Ocean and Abreast into Prosperity", the event will bring together existing ASEAN energy cooperation platforms such as the East Asia Summit



Clean Energy Forum, ASEAN +3 Clean Roundtable Dialogue and the China-ASEAN Capacity Building Programme, as well as other dialogues and cooperation activities from governments and the industry.

7 MOS Low is also taking this opportunity to deepen economic relations with her counterparts. While in Nanning, MOS Low met Chairman of the Guangxi Zhuang autonomous region, Lan Tianli. She is also expected to meet with counterparts from China National Energy Administration, Lao PDR and Hainan Province on the sidelines of the upcoming CACEW.
