NEW MANAGING DIRECTOR AND BOARD CHANGES AT ENTERPRISE SINGAPORE

1. The Ministry of Trade and Industry (MTI) today announced the appointment of a new Managing Director (MD) and Board Members at Enterprise Singapore (EnterpriseSG).

Changes in appointment of Managing Director

2. Ms Cindy Khoo, currently the Deputy Secretary (Strategy Group) at the Prime Minister's Office (PMO), will be concurrently appointed as MD, EnterpriseSG on 1 March 2024. She takes over from Mr Jeffrey Siow, who stepped down from his appointment at EnterpriseSG on 31 December 2023. Ms Khoo will relinquish her appointment at PMO to fully assume her role at EnterpriseSG on 1 April 2024.

Ms Cindy Khoo (丘晓晴)

3. Ms Khoo started her career in the Singapore Public Service at MTI as a trade officer. Since then, she has handled different portfolios in the Ministry of Health, PMO, Public Service Division and the Ministry of Education. She joined the Strategy Group, PMO in 2019, where she oversaw functions such as Strategic Planning; Futures; and Organisational Development, before taking on her current role, as Deputy Secretary (Strategy Group) in September 2021.



4. Ms Khoo has demonstrated strong leadership in her current and previous roles, and possesses deep expertise in Public Sector governance and processes. She has in-depth knowledge of sustainability and economic issues, drawn from her work at the Strategy Group, PMO.

Mr Jeffrey Siow Chen Siang (萧振祥)

5. Mr Jeffrey Siow was EnterpriseSG's first Managing Director and Chief Operating Officer. Appointed in September 2021, Mr Siow led EnterpriseSG to develop new strategies to uplift local enterprises, transform key industries and scale up promising enterprises. During his tenure, he deepened relationships with key partners such as trade associations and chambers, standards and accreditation bodies, unions and business leaders, and expanded EnterpriseSG's global reach by strengthening connections to foreign governments



and business organisations. Mr Siow also led the transformation of EnterpriseSG's internal operations through digitalisation and process re-



engineering. As Chairman of SEEDS Capital, EnterpriseSG's investment arm, Mr Siow led government investments in Singapore-based early stage start-ups, overseeing a fund size of over \$500M and more than 150 portfolio companies.

6. He was appointed Second Permanent Secretary of the Ministry of Manpower on 1 January 2024. Prior to these roles, Mr Siow was Principal Private Secretary to Prime Minister Lee Hsien Loong. He has also served in other capacities at the Ministries of Transport, Education, and Manpower and at the PMO.
