## **New CCCS Board Member**



Mr Goh Yihan, Senior Counsel

Mr Goh was appointed to his current role as a Deputy Attorney-General ("**DAG**") with effect from 1 January 2025 for a term of 2 years.

Prior to his appointment as DAG, Mr. Goh was appointed a Judicial Commissioner of the Supreme Court on 1 July 2022 and Judge of the Supreme Court on 1 October 2023. Before he joined the Supreme Court, Mr Goh was with the Yong Pung How School of Law, Singapore Management University ("SMU"), from 2014 to 2022 and served as Dean from 2017 to 2022. He was appointed as Professor of Law in SMU in 2019. He was also with the National University of Singapore's Faculty of Law from 2008 to 2014.

Before academia, Mr Goh served as a Justices' Law Clerk and subsequently as an Assistant Registrar at the Supreme Court. He was called to the Singapore Bar in 2011 and was appointed as Senior Counsel in January 2021. His areas of focus are finance, securities, banking, complex commercial cases; corporate insolvency; company, trusts and insolvency; intellectual property or information technology; and tort claims.

Apart from his duties as DAG, Mr Goh is on the Senate of the Singapore Academy of Law ("SAL") and is also a board member of the SAL and the Singapore Institute of Legal Education. He is also Co-Chair of the SAL Legal Research and Publications Committee and Co-Chair of the SAL Learning and Professional Development Committee.
