The team recognised the challenges and impact on businesses arising from the two Phase 2 (Heightened Alert) periods, and Stabilisation Phase. Hence, using data available to IRAS, the team developed a model to identify eligible recipients, and automatically disbursed all three RSS payouts to the majority of the eligible owner and tenant-occupiers. These recipients would not be required to submit an application to IRAS.

Could you share briefly on what was the impetus that eventually led to the initiative, and how did you motivate yourself/your team to pursue it?

In 2021, due to the tightened COVID-19 Safe Management Measures, there was an urgent need to provide financial assistance to affected businesses. One such support was on their rental expense.

While the Government had introduced rental assistance in the form of the Rental Relief Framework in 2020, there were inherent difficulties as it required the rental relief to be administered indirectly via landlords.

Hence, when 2021 came, IRAS reviewed the policy parameters and design, and developed a business-friendly approach to administer rental support quickly to businesses.

What were the challenges that you / your team encountered, and how did you / your team overcome them?

A key challenge faced was having to disburse the Rental Support Scheme ("RSS") payout quickly to support the affected businesses during the tightened Safe Management Measures.
